(A) INSTRUCTION FOR APPLICATION OF REGISTRATION:-

Attested copies of the following Documents are required to be furnished along with application form of registration.

- (1) Proof for address like; Ration card, Electoral identity card, Passport, Driving License, LIC policy, Property tax bill, Telephone bill, Electricity bill, Certificate issued by Chairman / Secretary of the residential premises etc.
- (2) Certificate of degree / diploma obtained by the applicant.

- iv. Eligibility:
 - (a) A degree in Civil Engineering/ Architecture or Diploma in Architecture equivalent to degree Architecture or its equivalent qualification recognized by All India Board of Technical Education & with minimum 3 years Experience (after attaining the degree) in Construction work at a responsible position in any Private/ Government/ Semi-Government.

(b) Diploma in Civil engineering recognized by State Board of Technical Examinations of any State in India with Minimum 5 years experience (after attaining the diploma) in Construction work at a responsible position in any private/ Government/ Semi Government.

OR

(c) Bachelor's Degree with specialized training in building in construction technology or Diploma in Building Construction Technology from a recognized institute with minimum 3 years experience (after attaining the degree/ diploma) in Construction work at a responsible position in any Private / Government / Semi Government.

(2) **GRADE-2**:

- i. **Scope of Work:** Execution of low rise frame structure building having more than ground floor+2 upper floors.All Low Rise Buildings excluding above Grade-1.
- ii. **Registration Fees:** Rs. 4000/- for five years
- iii. Renewal Fees: Rs. 4000/- for every five years
- iv. Eligibility:
 - (a) A degree in Civil Engineering/ Architecture or Diploma in Architecture equivalent to degree in Architecture or its equivalent qualification recognized by All India Board of Technical Education & with minimum 1 year Experience (after attaining the degree) in Construction work at a responsible position in any Private/ Government/ Semi-Government.

OR

(b) Diploma in Civil engineering recognized by State Board of Technical Examinations of any State in India with Minimum 3 years experience (after attaining the diploma) in Construction work at a responsible position in any private/ Government/ Semi Government.

OR

(c) Bachelor's Degree with specialized training in building in construction technology or Diploma in Building Construction Technology from a recognized institute with minimum 1 years experience (after attaining the degree/ diploma) in Construction work at a responsible position in any Private / Government / Semi Government.
